This Letter was written by Queen Victoria on March 17 1850, St Patricks' Day to mark All Ireland, then sent to King Dom Ferdinand II of Portugal, who personally delivered it to Prince Marcos Manoel, who was made King John II of England, and King of the United Kingdom of Great Britain and All Ireland in 1869.

Queen Victoria's watermark is "J WHATMAN TURKEY MILL 1850".


