**Statement of Claim in support of Joseph Gregory Hallett

Joseph Gregory Hallett declares that King George V of the United Kingdom was illegitimate. His natural biological father was not Edward VII, but Tsar Alexander III.

The title in question is King of the United Kingdom and the British Dominions, and Emperor of India, abbreviated to King of the United Kingdom.

King George V of the United Kingdom and the British Dominions was born George Frederick Ernest Albert (3 June 1865–20 January 1936). His parents were purportedly Bertie, Prince of Wales (9 November 1841–6 May 1910) who became King Edward VII of the United Kingdom (R. 22 January 1901–6 May 1910) and Alexandra, Princess of Wales (née Denmark) who became Queen consort of the United Kingdom.

However, the siring father of King George V on 29 September 1864 was actually Tsesarevich 'Sasha' Alexander (1845–94) who then killed his elder brother Grand Duke Nicholas 'Nixa' and married his fiancée widow to become and Tsar Alexander III (R. 1881–94).

George V erroneously ruled the United Kingdom from 6 May 1910 to 20 January 1936, when he was put to death early, to make the respectable papers on time.

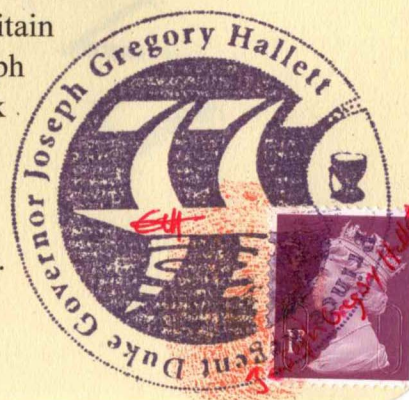

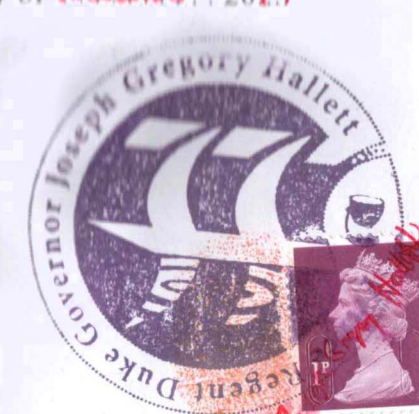

Tsar Nicholas II (R. 1894–1917) and King George V (R. 1910–36) have mothers who are sisters (Princess Dagmar and Alexandra, PoW) and this became the official excuse for their likeness, but in the reality of conceptions, they had the same father – Tsar ‘Sasha’ Alexander III – making them brothers who were cousins. Here’s how the wrong side of the sheets were ruffled . . .

The Illegitimate Conception of King George V of the United Kingdom & The Russo-Danish takeover of the British Monarchy

Alexandra, Princess of Wales (1844–1925) was from Denmark. She hated the Germans and everything about them, including her mother-in-law, Queen Victoria, whose mother, Princess Victoire Louise was German.

Princess Alexandra passed this hatred of Germans onto her firstborn son, Prince Eddy (1864–1892/1933+). He officially died in 1892, but was still alive in 1933.

Tsar Nicholas II of Russia (R. 1894–1917) and King George V of the UK (R. 1910–36) had mothers who were sisters – Princess Dagmar of Denmark & Russia, and Alexandra, Princess of Wales. This became the official excuse for their likeness, but in the reality of conceptions, Tsar Nicholas II (Russia) and King George V (UK) had the same father – Tsesarevich ‘Sasha’ Alexander (1845–94) who became Tsar Alexander III (R. 1881–94).

After giving birth to the “backward” Prince Eddy two months premature on 8 January 1864, hating the Germans, hating and avoiding her husband Bertie, Prince of Wales as sperm provider, Alexandra, Princess of Wales purposefully sabotaged the British Throne by conceiving her second child with Tsesarevich Alexander ‘Sasha’ (1845–94), whose elder brother, Grand Duke Tsesarevich Nicholas Alexandrovich ‘Nixa’ (1843–65) was Heir Apparent to the Tsar of Russia, Alexander II (R. 1855–81).

Alexandra, Princess of Wales conceived a child that was to become King George V of England (b. 3 June 1865), but the father was not from England, and the child was conceived in Denmark.



The Danish Alexandra, Princess of Wales conceived 26–30 September 1864 at her younger sister's formal engagement betrothal to the first in line to the Russian Throne, Grand Duke Tsesarevich Nicholas Alexandrovich 'Nixa' in Denmark, six (6) miles north of Copenhagen, at Bernstorff Palace.

A Black Moon month has Two New Moons in the same month. "September 1864" was a Black Moon month, and this made it ideal to conceive a Monarch.

Heir to the Russian throne, Grand Duke Tsesarevich 'Nixa', had fallen in love with photographs of Princess Maria 'Dagmar' Feodorovna of Denmark. He visited Copenhagen in August 1864, then wrote to his mother, Empress Maria Alexandrovna (40), on 24 August 1864, "Dagmar was more beautiful than I had imagined".

Grand Duke Tsesarevich 'Nixa' proposed to Dagmar on his 21st birthday, on 20 September 1864 in the Bernstorff Palace Gardens.¹

This was quickly followed by a formal betrothal that brought her sister, Alexandra, Princess of Wales (19) together with his brother, Tsesarevich 'Sasha' Alexander of Russia (20) as 'sister to the fiancée bride' and 'brother to the fiancé groom'. Both were currently from out of town, both were familiar with the surroundings, and each other, since their families were often photographed holidaying together in Denmark.

The familiar 'sister to the fiancée bride' and 'brother to the fiancé groom' were given a time frame from 20–30 September 1864 to conceive under the Black Moon Month, but first they had to get rid of Bertie, Prince of Wales – later King Edward VII – so the Ship's Record would later confirm that King George V of England was born illegitimate.

Nixa's 20 September 1864 proposal was quickly followed by formal betrothal, which was quickly followed by a conception (26–30 September 1864). However it was not the fiancé or fiancée who conceived, but their respective brother and sister.

'Tsesarevich Alexander of Russia' sired an illegitimate child with 'Alexandra, Princess of Wales', becoming pregnant with the future King George V of England (R. 1910–36).

The newly engaged Grand Duke Tsesarevich 'Nixa' Nicholas then left Denmark by paddle steamer for Genoa, Italy and Nice in the south of France, and it was "During a trip to Italy at the end of 1864, that Nicholas contracted what was wrongly diagnosed as rheumatism, but actually turned out to be tuberculosis."² While Nixa was sleeping on the Royal Yacht *Alexandria*, a Tuberculosis-laden cloth was wafted over him.

There were many Royal deaths in that period, by Medically Assisted Death M.A.D. : Prince Fernando of Portugal (15) died on 6 November 1861;

his brother King Pedro V of Portugal (R. 1853–61) on 11 November 1861 aged 24;

their brother Heir Presumptive Prince John of Portugal (19) died on 27 December 1861 ... all killed by 'Cholera or Typhoid'. In the middle of this ...

Prince consort Albert died of 'Pneumonia' on 14 December 1861 (Q. Victoria's husband).

These four killings by 'Cholera or Typhoid' and 'Pneumonia' within 51 days in 1861 were all Medically Assisted Deaths, and Tsesarevich 'Nixa's 1864–65 Tuberculosis was a continuation, rendering five (5) M.A.D. killings.

Russian Grand Duke Royal Runt Nicholas 'Nixa' (21) was engaged to Princess Maria Feodorovna 'Dagmar' of Denmark (16) from 20 September 1864 to his death on 24 April 1865. His younger brother then married her and became Tsar Alexander III (R. 1881–94).



Grand Duke Tsesarevich 'Nixa' contracted Tuberculosis on his outward journey from Denmark to Italy in October 1864. Since Grand Duke Nicholas (21) was the "Royal Runt" of the family, and both the elder Danish and Russian Royal Family were more keen on the much stronger Tsesarevich Alexander (20), there seems to have been an agreement for action and silence.

Tsesarevich Alexander (later Tsar Alexander III) and their father Tsar Alexander II had the strongest motivations. This was confirmed by their later actions ...

After Tuberculosis was wafted over and contracted by Nixa in October 1864, it was misdiagnosed as 'Rheumatism' which made any treatment useless. The results of Tuberculosis Meningitis were typically disfiguring, placing Nixa at least outside Kingship, if not dead.

Six months later, Grand Duke Nicholas' health suddenly deteriorated and he died on 24 April 1865.

Their father, Tsar Alexander II (46) travelled from St Petersburg to "Dijon" (or 'Digne') in France to see his son, Nixa. His wife, Empress Maria Alexandrovna (40) was there with Nixa's brother, Tsesarevich Alexander (20), whom the fiancée Princess Dagmar considered to be Nixa's only friend – typical of a Runt. Nixa's younger brothers were also reportedly there, with his younger sister unconfirmed.³

Fiancée Princess Dagmar (17) and her mother, Louise, Queen consort of Denmark (37) and brother Prince Frederick (21) then hurried to Nice, and from there to "Dijon" (but probably "Digne") arriving on 22 April 1865. Dagmar was allowed to see her fiancée, Grand Duke Tsesarevich 'Nixa' Nicholas, on 23 April 1865. Nixa died the following day from purposeful misdiagnosis, at the age of 21.⁴

Tsesarevich Alexander then proposed to the grieving Princess Dagmar as soon as his brother Nicholas was dead, and over the body. This was a bit of a faux pas as it showed planning and motivation. This was backed up by Tsesarevich Alexander's Russian parents who made the same request a few days later, and again by pestering letters.

It was the fiancée widow Dagmar's mother, Louise, Queen consort of Denmark, who slowed things down pleading to "observe a year of mourning".

Seven (7) months after Nixa's engagement, and the pregnancy of his future sister-in-law, Alexandra, Princess of Wales (19), to his younger brother Tsesarevich Alexander (20), with Nixa's illness and cause of death planned, misdiagnosed, then obfuscated, and the location of his death uncertain, no questions were asked as to who caused the death, who profited, or the reasons and motivations behind it.

Nixa either died in Italy, or in France, Nice, Provence-Alpes-Côte d'Azur, or Digne, Côte d'Azur; or Dijon, Côte-d'Or.

Grand Duke Tsesarevich 'Nixa' Nicholas' Illness and Death

Like his mother, Grand Duke Tsesarevich 'Nixa' Nicholas had weak lungs, which provided sufficient reason to send him south for winter. Tuberculosis was an ideal disease for him to 'acquire' as it was 'of the lungs'. All the doctors had to do was misdiagnose Nixa's condition as something less harmful, like Rheumatism, then Bronchitis, each analysis acknowledging some symptoms and denying others, causing the required delay, as recovery required immediate attention.

Empress Maria Fyodorovna: "During a trip to Italy at the end of 1864, Nicholas contracted what was wrongly diagnosed as Rheumatism, but actually turned out to be Tuberculosis."

In Italy, Nixa developed back pain, a stiff neck, and sensitivity to noise and light, so they headed for clear weather and high hills, his whereabouts obfuscated as: Nice; or in the 170 km of hills between Nice and Marseille; or in "Digne", "Provence-Alpes-Côte d'Azur" (150 km inland NW by road & train); or in "Dijon" the capital of "Côte-d'Or" in the Burgundy region (650 km inland NW by road & train).

There were also different accounts of the cause of his death including Rheumatism, Bronchitis, Meningitis, Viral Meningitis, Cerebrospinal Meningitis, Bacterial Meningitis, standard Tuberculosis, and Tuberculosis Meningitis ... all of which postponed the real treatment, being rest and extract of Willow bark or *Spiraea* shrub – both 'Aspirin'.

Tuberculosis ("Consumption") caused a quarter of the deaths in Europe in the 1860s. The lungs were attacked resulting in coughing, sneezing and spitting with blood-tinged sputum, enveloping the central nervous system, resulting in fever, headache, confusion, then coma. If untreated, the various strains of mycobacteria had a kill rate over 50 %.

Tuberculosis is treated with simple Aspirin, which reduces complications and extends life. Aspirin was available as the extract of Willow bark and the common *Spiraea* shrub of the family Rosaceae which grew locally in temperate areas of the Northern Hemisphere (80–100 species) including France. Aspirin became available as the pill 'Meadowsweet' too late in 1898.

Tuberculosis was identified as a single disease in the 1820s and named "Tuberculosis" in 1839, then as "TB", with the active bacillus characterised in 1882, then identified as contagious in the 1880s, with the first treatment available in 1906. A cure was realised in 1946 with the antibiotic 'streptomycin'.

Rheumatism was a 'Victorian blame-all' for 200 different conditions, mainly arthritis, characterised by chronic intermittent pain mainly in the back, neck and joints, but no sensitivity to noise and light. Rheumatism was treated with warm clear weather in the hills, and herbs, so they headed for the hills in the south of France, which took several days and caused several days delay. 'Rheumatism' is no longer recognised as a disorder.

Bronchitis usually develops out of the common cold. It is an inflammation of the mucous membranes of the throat and lungs, resulting in a rough cough that produces sputum. **Acute Bronchitis** is caused by a virus (90 % of cases) or bacteria (10 %) with a rapid onset and lasts less than three weeks resulting in a sore throat, short breath, fatigue, runny nose, nasal congestion, low-grade fever, pleurisy, and the production of sputum. It usually resolves quickly, even without treatment. **Chronic Bronchitis** persists for three months or more, over at least two years, resulting in a rough cough that produces yellow/green sputum with specks of blood – most commonly caused by air pollution and cigarettes.

Meningitis has symptoms which can develop in any order, not all the symptoms may occur, and it can be difficult to distinguish from less serious infections. Nixa could seem perfectly well, then extremely ill within hours. Symptoms include stiff neck, aching muscles and joints, aversion to bright lights, severe headache, drowsy, fever, stomach pain, vomiting, diarrhea, and cold hands and feet. Meningitis is an inflammation of the protective membranes covering the brain and spinal cord with a chance that the blood-brain barrier can be crossed. Meningitis is considered a medical emergency.

Viral Meningitis is the most common, treated with rest and painkillers like Willow bark/Spiraea shrub (Aspirin). There is still no vaccine against most viral meningitis and antibiotics don't help.

Cerebrospinal Meningitis is an inflammation of the lining of the brain and spinal cord, often resulting in blood poisoning – septicemia.

Bacterial meningitis is less common, but can progress very rapidly from a headache, fever and drowsiness, into deep coma. The bacteria causing bacterial meningitis are very common, usually harmless, and found naturally in the nose and throat of young adults. They can be spread through prolonged close contact, coughing, sneezing or kissing, where the germs overwhelm the body's immune system, causing septicemia, and the blood no longer circulating, resulting in shock and dehydration.

Meningococcal group B bacteria requires immediate blood tests seeking the 'bacteria causing the infection' and the 'markers for inflammation'. There is still no safe effective vaccine against Meningococcal B.

Tuberculosis Meningitis is an infection of the membranes, which envelops the central nervous system (meninges) and is the most common form of central nervous system tuberculosis. The symptoms are fever and headaches, with an 80 % chance of a stiff neck and intolerance of bright light (called 'Meningism'). This is followed by confusion, then coma, then death.

Infection begins in the lungs and spreads to the central nervous system with the inflammation concentrated towards the base of the brain and 25 % crossing the blood-brain barrier. These symptoms mimic those of space-occupying lesions.

The diagnosis of Tuberculosis meningitis is still very complicated and treatment has to begin before the results are known, which takes two weeks today. Patients are treated on the basis of suspicion only as over half of TB meningitis cannot be confirmed microbiologically. Extract of Willow bark/Spiraea (Aspirin) reduces complications such as brain tissue damage and improves the chance of survival.

At the time, 1864/65, treatment for infections like Meningitis, were still based on medicinal folklore prescribed over 2,000 years prior. These often included mold extracts and plant materials. With misdiagnosis, therapeutics can become antagonistic, so the doctors tended towards caution rather than the death of a royal – regicide. Peanut mold, for instance, could be used as a deathly poison.

The modern treatment is intravenous fluids straight to the intestine, oxygen and 'Antibiosis' which weren't characterised until 1877. They were renamed 'Antibiotics' in 1942.

The Death Scenario

Nixa was given some form of contagious Tuberculosis, wafting it over his bed while he slept on his outward journey from Denmark to Italy. Symptoms arose and these were misdiagnosed as 'Rheumatism' and 'Bronchitis', or 'simple Tuberculosis' – non-life threatening.

The diagnosis of Rheumatism – a Victoria blame-all – resulted in delay, taking a carriage ride from Italy to the south of France, which was not 'rest', then into the hills where conflicting 'sickness location' reports indicate purposeful obfuscation for M.A.D.

This was followed by ignoring some symptoms and watching the illness, misdiagnosed as Rheumatism, Bronchitis, progressed into fully flared 'Tuberculosis Meningitis' by acknowledging the back pain and stiff neck and treating it, and acknowledging the sensitivity to noise and light, but not treating it. Rather this was not mentioned, and the doctors pulled the curtains and moved around Nixa quietly.

When the traditional symptoms of simple tuberculosis didn't emerge – coughing, sneezing and spitting with blood-tinged sputum – it was recorded that it couldn't be any form of Tuberculosis.

When the symptoms of Tuberculosis Meningitis emerged with 'severe headache, stiff neck and aversion to bright lights and noise, and/or cold hands and feet, aching muscles and joints, stomach pain, vomiting, diarrhea, fever, drowsy or unconscious', the extra symptoms were attributed back to Rheumatism – including myositis, muscle inflammation causing pain, tenderness, and spasm – and a hot compress on the forehead ... then it's just a short wait until Nixa becomes extremely ill and there's no saving him.

Nixa had 'Tuberculosis Meningitis' which had to be treated immediately and without delay, beginning with extract of Willow bark/Spiraea (Aspirin). This is especially the case with a Royal, and especially a Royal firstborn son. Anything else was borderline Regicide. With all their doctors, when a young adult Royal Runt dies of a misdiagnosed condition, there is a high probability it was M.A.D. Regicide – 'Medically Assisted Death'.

Viral, Cerebrospinal, Bacterial and Tuberculosis Meningitis can cause learning impairment, behavioural problems, epilepsy, restricted movement and coordination, deafness, blindness, scarred skin, damaged bones and joints, kidney failure, loss of limbs, and death. If any of these conditions occurred and pretty boy Nixa was malformed beyond acceptable for a Tsar, his doctors could well have been required to turn the 'therapeutics' over towards 'antagonistics' causing death at the time requested – the day after Nixa's fiancée arrived.

Once Princess Dagmar had visited Grand Duke Tsesarevich Nicholas, his Aspirin could have been exchanged for a placebo and his claimed 'therapeutics exchanged for known antagonistics, as they were.

The typical method was concentrated snuff – cocaine with an increased amount of heroin added. Today, morphine is used. This would explain why Nixa died the day after his fiancée Princess Dagmar (17) and her mother, Louise, Queen consort of Denmark (37) arrived at his bedside. It also confirmed his identity before death, but in an undisclosed location.

Grand Duke Tsesarevich Nicholas Alexandrovich 'Nixa's death is officially recorded as 'Cerebrospinal Meningitis', but I prefer the cause, 'Tuberculosis Meningitis'.

Death of Grand Duke Nicholas preceded by Tsesarevich Alexander siring George V

The death and the illegitimate birth were to have huge consequences all the way to the last bombing raids of World War Two.

Tsesarevich 'Nixa' Nicholas was the "Royal Runt" who had to be replaced, and Tsesarevich 'Sasha' Alexander had to prove he wasn't a Royal Runt by getting Princess Alexandra pregnant. Marrying Alexandra's sister would prove his necessary ruthlessness. Nixa on the other hand, was the 'identified Royal Runt' too soft to rule, and would render Russia a laughing stock.

The designed outcome contained the promise of Russian and Danish Royal political influence over Britain, ultimately resulting in the illegitimate King George V (R. 1910–36) secretly evacuating the Romanov Royal Family out of Russia in 1917/18, with Windsor Castle as the base of operations, and a very bad doppelgänger Romanov Family executed ... "very bad" in that some Romanov remains were made up of three different bodies. They were then positively identified using Prince Philip's DNA, but Prince Philip had sphere of influence over the DNA testing, and the most to gain from covering this story up.

The real history of the real Romanov Family escape was meant to be discovered soon after the doppelgänger Romanov remains were exhumed. As a result, the Russian Orthodox Church has refused to confirm the remains as 'real'. Even amongst scientists the debate continues, largely motivated by continuation of funding. This has resulted in debate without integrity, in which the real Romanov Royal Family escaped to the center of Russia, the center of Ireland, Spain, Yugoslavia, the south of France, and Australia, with the assistance of their brother and uncle, King George V of Great Britain and Ireland. Recent contacts have expanded on these locations, to be published elsewhere.

Conveniently, the Runt Heir, Grand Duke Tsesarevich 'Nixa' Nicholas died of Rheumatism, Bronchitis, Meningitis, Viral Meningitis, Cerebrospinal Meningitis, Bacterial Meningitis, Tuberculosis, or Tuberculosis Meningitis on 24 April 1865 (N.S.) or 12 April 1865 (O.S.) ... but was finally killed with cocaine and heroin – concentrated snuff – in the various locations of Nice; or in the 170 km of hills between Nice and Marseille; or in "Digne", "Provence-Alpes-Côte d'Azur" (150 km inland NW by road & train); or in "Dijon" the capital of "Côte-d'Or" in the Burgundy region (650 km inland NW by road & train).

Different historical sources give five (5) different causes of death; *The New-York Times* reported on July 11, 1865 "an attack of bronchitis (some sources quote meningitis)" ... in five (5) different locations ... so "55" meaning 'occult secret'.

Denmark changed to the New Style Gregorian Calendar in 1700, England in 1752, Sweden in 1753, and Russia on 14 February 1918, but the Russian Orthodox Church still follows the Old Style Julian Calendar. In the 1800s, this was a 12-day difference.

The Russian Grand Duke Nixa's death was 'convenient' as it was just 70 days before King George V of England was born.

In 1864, the Russian Royal Family had two yachts operating, the small side-wheeled paddle steamer *Alexandria* (1851–1906) designed entirely for speed and service; and the twin-paddle steamer *Standart* (1857–92) built for Nixa's father, Emperor Alexander II.

Tsesarevich 'Sasha' Alexander (20) had sired a British Royal Prince and caused the death of his 'friend' and elder brother Tsesarevich 'Nixa' Nicholas (21), rendering Sasha the future Tsar Alexander III of Russia (R. 1881–94).

There was plenty of motivation for Sasha to remove his sensitive weak-lunged elder "Royal Runt" brother Nixa before Nixa took the Throne and his physical condition and soft-touch weakened all of Russia. Such a scenario also had complicity from their father, Tsar Alexander II (R. 1855–81). This has resulted in a complicity of silence to this day and has resulted in a pact of silence between Russia and Denmark, which Germany exploited.

The younger sister of Alexandra, Princess of Wales (19), Princess Maria Feodorovna 'Dagmar' of Denmark (16–17) was engaged to Grand Duke 'Nixa' Nicholas (21) from 20 September 1864 to his death on 24 April 1865.

According to 'historical records', while terminally ill from Tuberculosis Meningitis, passed off as Rheumatism, followed by an attack of Bronchitis, Nixa's dying wish was his fiancée of seven (7) months, Princess Dagmar (17) should marry his younger brother and only friend Tsesarevich Alexander (20).

However, the scheming of this also came from Tsesarevich 'Nixa's' parents – the Emperor and Empress of Russia – in the days after his death, with the blame continually shifted between the players, creating four or more versions of how Tsesarevich 'Sash' Alexander (20) proposed to Princess Dagmar (17).

This put another layer of confusion on unraveling the scheme which gave the Russian and Danish Royal Families influence over the British Royal family, and the future King George V (R. 1910–36) about to be born 70 days after Nixa died.

It was as if they had advanced knowledge of the 1917 Russian Revolution and the Communist takeover which would ultimately abolish their Romanov Monarchy on 15 March 1917, and for this, they would need an escape route, so they were breeding one.

Since nothing in politics happens by accident, and everything that happens at this level is planned ... it is not out of the question that this was the case. It was known these events were due to occur in half-a-century later (52 years) and to prepare for them, or these events were retribution from the cuckolded King Edward VII, and engineered to occur in George V's reign.

Since Births, Deaths and Marriages are the modus operandi of Royal Families, it was Births, Deaths and Marriages that were planned to engineer each other's history.

The fiancée-widow "Princess Dagmar accompanied Nicholas' grieving parents, the Emperor and Empress of Russia, to the Battenberg's Heiligenberg Castle in Hesse-Darmstadt, where they spent several days together at the end of April 1865. This was where the idea was first [third] muted of the near widow, Princess Dagmar, marrying the new Heir to the Russian throne, Nicholas' brother Tsesarevich Alexander."⁵

Heiligenberg Castle is 14 km south of Darmstadt on the 'Conquering Occult' Line of Destiny with panoramic views of the Rhineland as far as the Palatinate. It was the Battenberg's Palace, and it was the Battenbergs who were their hosts entertaining them.

The Battenbergs were later recognised as the great extortionists under their 1917 name "Mountbatten" ... including Lord Louis Mountbatten, who operated a near identical racket for his nephew Prince Philip. All that is required is a death and an illegitimate birth.

There are now four versions of how Tsesarevich Alexander 'Sasha' (20) proposed to Princess Dagmar (17), as:

1. Tsesarevich Nicholas' dying wish;
2. Tsesarevich Alexander's proposal over his elder brother's body as soon as he'd died;
3. Plans of Emperor & Empress of Russia at Battenberg's Heiligenberg Castle a few days later;
4. Continual pestering letters from the Emperor and Empress of Russia to Princess Dagmar as though, for them, it had to happen.

Prince Louis Battenberg (1854–1921) was ten (10) at the time of their visit. The Emperor and Empress of Russia continued visiting the Battenbergs at Heiligenberg Castle until 1914, as themselves, their children, and their grandchildren.

Although the Battenberg & Mountbatten families were illegitimate, they held some sway in their Heiligenberg Castle at it was on the 'Conquering Occult' Line. These are Earth's Secret Lines of Destiny, which are proven to have held sway over Europe, manifesting eight (8) Kaisers ≈ Tsar, Caesar, Emperor, King.

The Battenbergs were an illegitimate branch of the German Royal Family, and survived with Prince Louis Battenberg emigrating to England soon after. He was then admitted by the Board of Admiralty without a medical certificate, contrary to regulations, and joined the British Royal Navy on 3 October 1868, aged 14, by enlisting as a naval cadet on Nelson's old flagship, HMS *Victory*, permanently moored in Portsmouth across the water from the Isle of Wight.

This immediately made Prince Louis Battenberg a naturalised British subject with unlimited shore leave access to Osborne House, where Queen Victoria lived.

Queen Victoria rarely visited London, and came up with every excuse not to visit, including hiring crisis actors to make lame assassination attempts whenever she turned up.

Prince Louis Battenberg then teamed up with his son, Lord Louis Mountbatten. In the 1953 Disney movie 'Peter Pan', Prince Louis Battenberg and his son, Lord Louis Mountbatten are represented as 'Twins in Raccoon suits' – as both 'racketeers & raconteurs'.

Inviting Prince Louis Battenberg to England was to prove one of the single biggest disasters for the illegitimate side of the British Royal family, causing the incumbent Flat Lie British Royal family to unravel each successive de-generation.

It was, however, to prove Her Majesty's Victory for her firstborn and only legitimate son, Prince Marcos Manoel, who became King John II of the United Kingdom (1869–1910).

That's what you get with a pair of Racketeering Raconteurs, especially when they're an illegitimate branch of a foreign Royal family specialising in extortion and sexual compromise. The fact that Battenberg was raised on the 'Conquering Occult Line' added another subconscious compulsion to the mix, and bore influence through history accordingly.

The Battenberg/Mountbatten family extortion of the British Royal family began with:

1. King Edward VII of England was not the firstborn son, and was born bigamously and illegitimate, and therefore three times an illegitimate King of England (R. 1901–10);
2. The already married Alexandra, Princess of Wales (Danish) copulated with Tsesarevich Alexander 'Sasha' of Russia, and conceived the British Prince George, who later became King George V of the United Kingdom (R. 1910–36);
3. King Edward VII of England did not sire King George V of England (illegitimate);
4. King Edward VII's eldest son was Prince Eddy, whose death was faked on 14 January 1892, with rocks in his coffin. Prince Eddy was replaced by his younger brother, the illegitimate Russian-Danish son who became King George V of the United Kingdom.

Battenberg/Mountbatten extortion of the Russian and Danish Royal Families began with:

- 1st: Emperor Alexander II of Russia and his second-born son's Regicide of the 'Royal Runt' Grand Duke 'Nixa' Nicholas (21) on 24 April 1865; and
- 2nd: The Russian Grand Duke Tsesarevich 'Sasha' Alexander's proposal to the Danish Princess Maria Feodorovna 'Dagmar' of Denmark (17) over the body of their brother and fiancée, the Royal Runt Grand Duke 'Nixa' Nicholas (21) on 24 April 1865;
- 3rd: Immediately followed by debriefings and other proposals by the Russian Royal Family to the Danish Princess Maria Feodorovna 'Dagmar' of Denmark (17) in Battenberg's Heiligenberg Castle ... which was a center of sexually based extortion in Europe.

This placed the illegitimate German Royal Prince Louis Battenberg (1854–1921) and his son Lord Louis Battenberg / Mountbatten (1900–79) at the forefront of British, Russian and Danish Royal family affairs, and as the leading racketeer & raconteur extortionists.

Information regarding illegitimacy of the future King George V was known by the Danish, Russian and German Royal Families, but hidden by the British Royal family.

This was to prove a huge influence over territories, and wars over territories, from the concurrent Schleswig-Holstein Question Wars (1848–50 & 1 February–30 October 1864) ... to WWII (1939–45), followed by the Cold War, and Queen Elizabeth II signing over the United Kingdom to the European Union on 1 January 1973, and the non-resolution of this causing British Prime Ministers to continually resign amidst snap elections, including 2019.

"After Dagmar returned to Denmark in 1865, the Emperor and Empress of Russia continued to support the idea of her engagement to their new eldest surviving son and Heir ... Louise, Queen consort of Denmark then suggested they all wait until the official year of mourning has come to an end, and 'Who can say now whether, by that time, there will not be a change in Sasha's feelings, which came to him in the first moments of pain and anguish ... Let him tell her his decision himself'."⁶

Cover then had to be developed for Tsesarevich Alexander to distance himself from the regicide by M.A.D. ... and it came in this form ... Over the next year (April 1865–66) Tsesarevich Alexander (20/21) fell in love with one of his mother's ladies-in-waiting, Princess Maria Elimovna Mescherskaya (21/22).⁷

When the year of mourning ended on 24 April 1866, Tsesarevich Alexander refused point blank to marry Princess Dagmar. His father Emperor Alexander II explained that it was his duty, and this came before personal feelings.

Princess Maria Mescherskaya (22) was then introduced to the Russian industrialist, Count Pavel Pavlovich Demidov (27), the 2nd Prince of San Donato. They moved to Vienna and married soon after on 1 June 1867. Princess Maria then gave birth to a son in Vienna, and died two days later on 8 August 1868.

During this arrangement, Emperor Alexander II directed and ordered his son Tsesarevich Alexander embark to Denmark on his personal Royal Yacht *Standart* (1857–92) and propose to Princess Dagmar. The *Standart* was a 230-foot 895-ton twin-paddle steamer that could do 6 knots in calm fresh water, but through the Gulf of Finland and the Baltic Sea, it averaged 3.25 knots and took 9 days to complete the 800-mile journey.

Obviously Emperor Alexander II wanted his son to put on his best foot forward, so the new Grand Duke Alexander arrived to Denmark on the *Standart* in June 1866, and proposed to Dagmar the same month. Princess Dagmar then left Denmark with Sasha on 22 September for the "Russian Versailles", Peterhof Palace in St Petersburg.

Eighteen (18½) months after Grand Duke Nicholas died, the new Grand Duke Alexander married his new fiancée, Princess Dagmar on 9 November 1866, at St. Petersburg.

Neither of Princess Dagmar's parents attended the wedding, citing financial and domestic reasons. Since there were many photos of the two Royal Family's relaxing at each other's residences, this was out of order. It was more likely King Christian IX of Denmark and his Queen knew their new Russian relatives had Regicided their son-in-law to be, Grand Duke Nicholas, albeit 'Nixa the Runt'.

Only Dagmar's brother Prince Frederick of Denmark attended with a letter from their mother saying: "Difficult moments await you, and you will think them horrible ... give yourself up to the will of your husband in everything and do not protest even at the most unimaginable things, but convince yourself that such is the will of God. You will experience physical tortures ..."⁸

The second-in-line to the Russian throne was now first-in-line. Tsesarevich 'Sasha' Alexander had also sired the second-in-line to the British Throne, who would become first-in-line to the British Throne after the Russian-Danish instigated Jack the Ripper murders in 1888, followed by the death of Prince Eddy faked 1892, then moved to Glamis Castle.

The new Russian Heir, Tsesarevich 'Sasha' Alexander, had married his older brother's fiancée, Princess Dagmar, the sister of Alexandra, Princess of Wales, mother of his child.

The second-in-line to the British Throne would now have to become first-in-line to the British Throne, and for that, Prince Eddy had to die, or have his death faked, which is exactly what happened in January 1892.

It was a Royal Mafia operation, and those operational in it were only told enough of the story to motivate them. Few had the overall picture ...

In full Mafia fashion, Tsesarevich 'Sasha' Alexander had sired a child with the enemy, killed a family member, married the fiancée-widow, taken the Crown, and watched his son take the competition's Crown. It was a perfect hit – a Tactical Exercise Without Troops – a TEWT.

Like most Mafia and Royal exercises, it began and ended in the bedroom with 'Deaths, Marriages and Births', which the Royals advertise as "Births, Deaths and Marriages".

The Danish had married into the British Throne and bred with the Russians, thus breeding the Germans out of the British Throne altogether. This was Alexandra, Princess of Wales' curse and wish fulfilled!

This was beginning to look like a Danish-Russian coup over the British Throne by breeding, murder, faked death, compromise and extortion, and indeed it was.

This then gives credence to the Danish and Russians setting up the Jack the Ripper murders to remove Prince Eddy, as per Walter Sickert's belief ... and it was just such a coup.

So now we should firm up the details for the registered absence of Bertie, Prince of Wales – later King Edward VII (R. 1901–10) during the time his wife, Alexandra, Princess of Wales conceived Prince George – later King George V of the United Kingdom of Great Britain and all Ireland.

The Black Moon month for Conceiving a King

For those in the know about conceiving kings, 'the Black Moon conception of a Monarch' is very important to the Wiccans as well as the Danish, Swedish and Russian Royalty. It is part of their Myth and Legend – part of their King-making.

'Black Moon months' have two New Moons in the same Calendar month, and are rare, but in September 1864 there was a New Moon at 6:08 a.m. GMT on Thursday 1 September, and a second New Moon at 10:43 p.m. GMT on Friday 30 September 1864 – a Black Moon Month.

This was the same under Sea Time (Admiralty) and the Train times.

The same in local Copenhagen Land Time (CLT) was 50 minutes later from 6:58 a.m. CLT on Thursday 1 September, to 11:34 p.m. CLT on Friday 30 September 1864.

Greenwich Mean Time or GMT was discussed in 1840, but not certified until 1884 when Greenwich got the green light to become 0°0'0"E Longitude (E-W).

Copenhagen didn't align itself to GMT+1 until 1 January 1894.

Greenwich is located at 51°28'45"N, 0°0'0"E. Copenhagen is located at 55°40'34"N, 12°34'6"E. Copenhagen is 4° further North and 12° further East.

12°/360° = 0.033 x 1,560 minutes in a day = 52 minutes difference.

Bernstorff Palace was only 5 miles NNE of Copenhagen so the difference is negligible – $0^{\circ}4'35''\text{N}$, $0^{\circ}0'1''\text{E}$.

On 15 September 1864, the Full Moon in Greenwich was at 9:09 p.m. and in Copenhagen at exactly 10:00 p.m. The difference of 51 minutes accounted for the Latitude (+54 minutes) and the Longitude (- 3 minutes).

With a choice of 50, 51 or 52 minutes, the Danish, at the time, had adjusted their clocks 51 minutes ahead, so that their sunrises and sunsets occurred at exactly the same time as over London.

To the Russians, Scandinavians and Wiccans, any magic worked during this period of a Black Moon month is deemed to be especially powerful. The Russian Monarchies have a similar outlook – that this was a time to conceive 'a King', and will look preferentially to a King conceived during a Black Moon. A Russian Prince confirmed this to Joseph Gregory Hallett.

If a younger brother is conceived in a Black Moon month, some will attempt to depose the elder brother, especially if he is the 'Royal Runt', as was the case here. Since the Russian Tsesarevich 'Sasha' Alexander had sired a child in a Black Moon month, it was only natural, as 'Father of a future Black Moon King', to depose his elder brother, Grand Duke Nicholas 'Nixa' in April 1865 ... even disregarding, or including, that the child sired was a British Sovereign.

Carrying this further ... the Russians assisted in deposing Britain's eldest Heir son, Prince Eddy (1885–92) in favour of the Black Moon-conceived Prince George, and continued that assistance making him King George V of the United Kingdom, despite Prince Eddy surviving his 'death', and their official father, Bertie, Prince of Wales/King Edward VII also known to be illegitimate.

It was Bertie, Prince of Wales' illegitimacy that made this possible, and brought all the parties into a cohesive collusion, which included the British Navy and escort tender Frigates, and their records.

If we look to their futures, the lives of the entire Russian Monarchies were at stake.

This scenario turned favourable for the Russian Royal Wiccans, as it was King George V (R. 1910–36) who aided the escape of "his half-brother's Romanov Family" out of Russia in 1917/18 to central Russia, the center of Ireland, and to Spain, Yugoslavia, the south of France, and Australia. This was covered up by King George V officially doing the opposite and refusing them, but running the pro-Romanov operation from Windsor Castle.

Russia did not have a Black Moon month in 1864 since it was still on the Old Style Julian Calendar, but it did exist in Denmark and Sweden, so the engagement of Princess Dagmar of Denmark dictated the location to conceive, and Wiccan Sweden was chosen as the distraction for Bertie, Prince of Wales – typically 'hunting, feasting and a concubine'.

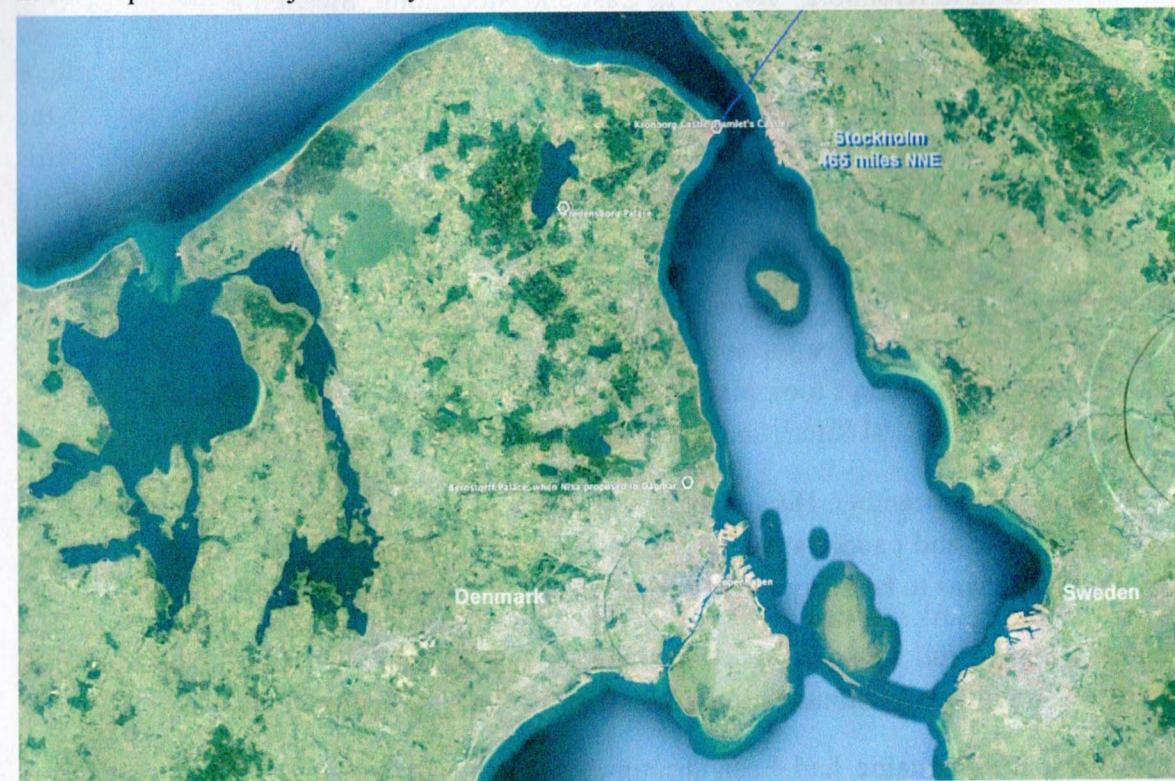
In Denmark, the Black Moon month was from the morning of 1 September to the evening of 30 September 1864.

In Denmark, the Black Moon month lasted between the two New moons, 6:58 a.m. Thursday 1 September to 11:34 p.m. to Friday 30 September 1864 Copenhagen Local Time (CLT)

giving 29 days, 16 hours and 36 minutes to 'Conceive a New King under the Black Moon'.⁹ This is when things became hugely important for the Wiccan Royals.

The UK, Denmark and Sweden were all on the New Style Gregorian Calendar while Russia was 12 days behind on the Old Style Julian Calendar. So the nine day (9) journey on the Royal paddle steamer *Standart* or *Alexandria* from St Petersburg to Denmark, would take the Romanovs twenty-one (21) days to arrive, and on their return journey, they would arrive three (3) days before they left.

Because Russia was on the Old Style Julian Calendar, it did not have a Black Moon month. That's why the soirée-conception had to happen in Denmark. Sweden was an alternative, but it wasn't home soil, but it was perfect for Bertie, Prince of Wales' chosen distraction modus operandi. He just always wanted to be distracted and dedicated his life to it.

The New moon set at 6:29 p.m. and the sun set 25 minutes later at 6:54 p.m., then Civil Twilight carried on until 7:32 p.m.,

Nautical Twilight until 8:21 p.m. and Astronomical Twilight until 9:17 p.m.

On Thursday 15 September 1864 the sun rose at 5:32 a.m.

The Full moon rose at 5:46 p.m. in a huge orange ball, then the sun set 31 minutes later at 6:17 p.m. Twilight carried on until 6:54 p.m., 7:39 p.m. and 8:28 p.m.

Then the moon became full at exactly 10:00 p.m. with 99.9% illumination.

It was a Hunter's moon, a Harvest moon and a perfect day. The moon then set at 4:57 a.m. and there was continuous twilight until the sun rose 35 minutes later at 5:32 a.m.

On Friday 30 September 1864 the New moon rose at 5:35 a.m. followed by sunrise 26 minutes later at 6:01 a.m. with 0.3% illumination.

The New moon set at 5:10 p.m. and 28 minutes later the sun set at 5:38 p.m.

Twilight carried on until 6:14 p.m., 6:57 p.m. and 7:42 p.m.

The new moon was at 11:34 p.m. CLT.

Removing Bertie, Prince of Wales out of Denmark

Historians describe Bertie, Prince of Wales' typical day as "hunting, feasting, then spending his evenings with a concubine".¹⁰ So by complicit arrangement Bertie was occupied with this, and at some point in the last ten (10) days of September 1864, Bertie, Prince of Wales would be exited out of Denmark to Sweden to carry out his typical day in another location. This occurred on 26 September 1864 and Bertie was away 24 days until 20 October 1864.

From Copenhagen it is 6 miles North to Bernstorff Palace. From Bernstorff Palace (formal engagement betrothal) it is 17 miles NNW to Fredensborg Palace. From Fredensborg Palace it is 10 miles WNW to Kronborg Castle ("Elsinore Castle" in Shakespeare's 'Hamlet' / Hallet) surrounded by moats and the Helsingør/Elsinore Harbour. From Copenhagen it is 25 miles north to Kronborg. Kronborg Castle to Stockholm, Sweden is 465 miles NNE.

Fredensborg Palace was designed as a hunting lodge and pleasure palace in the middle of the Østrup Vang forest with hunting paths hewn out of the forest. From just outside the front door you could shoot in seven directions, and by walking another 300 to 600 yards you could shoot in sixty directions, so it was a desired location for 'a hunting feasting and pleasure hound' like Bertie, Prince of Wales.

Despite being a hunting lodge, Fredensborg Palace was known as the 'Palace of Peace' and 'Peace Hill'. It was where important events like formal engagement betrothals, weddings, anniversaries and birthdays took place, but wasn't used by Grand Duke Nicholas, perhaps because he was the 'Royal Runt', and due to be killed off. Bernstorff Palace was used instead.

On Monday 26 September 1864, Bertie, Prince of Wales (23) boarded the *Osborne* at Kronborg Castle and paddle steamed off to Stockholm, Sweden doing 3 knots and jolly (ignorant). He was to be away twenty-four (24) days, returning four (4) days late.

This left four (4) full days plus 4–14 hours (100–110 hours) to conceive under the Black Moon, which ended at 6 minutes to midnight on Friday 30 September 1864.

This Black Moon magic had been drummed into the Russians and Scandinavians in children's fairytales and legends, especially amongst the Noble class. So these Nobles and Royals purposefully arranged events to create "their own king" for "their own purpose".

The sun was setting around 5:45 p.m. and the twilight carried on until the last light left around 8:00 p.m.

Alexandra, Princess of Wales (19) conceived a child to Tsesarevich 'Sasha' Alexander (20) around 2:34 p.m. on Thursday 29 September 1864, with 33 hours to spare on the Black Moon – 33 hours left to a complete New Moon and a completely New Monarch, and Monarchy, albeit still Flat Lie Royal, but this time a Russian-Danish Lie heaped upon the British Lie, with the British Royal family holding the shame, and therefore the Russians and Danish holding the all-powerful 'wild card' – to be made King George V of the United Kingdom of Great Britain and Ireland.

The British Royal Yachts and Escort

HMS *Aurora* had accompanied the Royal Yacht *Osborne* to and from Stockholm and HMS *Aurora*'s Petty Officer James Palk Cutler recorded the slow journey, that HMY *Osborne* took an extra four (4) days to return – nine (9) days rather than five (5) days. He later became Lieut. Commander James Cutler.

The hidden agenda was that Bertie, Prince of Wales would not return to Denmark until 0.01 a.m. 19 October 1864, or later. This ensured, by 'Ship's Record', that Bertie, Prince of Wales was definitely not the siring father to his pregnant wife Alexandra, Princess of Wales.

The hidden agenda was the agenda of the Black Moon magic, run by the Russian, Danish and Swedish Royals and Nobles, and thus, like 'Hamlet', a 'King' was created for their own purpose, by design, and for the demise of the British Royal family – illegitimate from Bertie, Prince of Wales, Edward VII (22 January 1901) and his illegitimate non-son, George V, 1910 to 1936. This meant no legitimate British Royals from 1901 to 1936.

In 1864, two British Royal Yachts were operating, both paddle steamers – HMY *Victoria* and *Albert* (*Osborne*) and the HMY *Victoria* and *Albert II*.

The twin paddle steamer, HMY *Victoria* and *Albert* was launched on 25 April 1843. It was owned and operated by the British Royal Navy as the first royal yacht powered by steam. At 1,034 tons with a 430 hp engine and two guns, it made 20 voyages and was then scrapped in 1868.

It was replaced with the HMY *Victoria* and *Albert II* as the 'Royal Yacht of the Sovereign of the United Kingdom', launched on 16 January 1855, and owned and operated by the Royal Navy until 1900. It was a 360-foot 2,470-ton, 240-crew paddle steamer that could make 15 knots in ideal conditions. She was scrapped in 1904.

When HMY *Victoria* and *Albert* was replaced by HMY *Victoria* and *Albert II* on 16 January 1855, HMY *Victoria* and *Albert* was renamed *Osborne* – which added to the required confusion as "Osborne House" was Queen Victoria's main residence on the Isle of Wight, where she lived – not in London.

So from 16 January 1855–68, the *Osborne* was at the beck and call of the Prince and Princess of Wales, as it was in 1864.

History-making ships and buildings are often destroyed after they have made that history, and the *Osborne* was no exception. She was destroyed in 1868, three (3) years after the Russo-Danish 29 September 1864 conception of the British King George V, and his birth on 3 June 1865.

Since much of our Royal history is obfuscated to maintain them falsely in the position of 'Royal Family', it is best to get the travel plans from the escort tender vessels – the Frigates that supported the Royal Yachts.

HMS *Aurora* was a wooden screw steam powered Frigate built in 1861. It sailed from Plymouth on 17 December 1863 and two days later, anchored off Osborne House on the Isle of Wight where Queen Victoria was in residence. HMS *Aurora* remained there for the two winter months (19 December 1863–25 February 1864) then made its way to Portsmouth.

Six months later, very early on the morning of 28 August 1864, HMS *Aurora* left Portsmouth and took nine (9) days (averaging 3.5 knots) to sail 750 miles to the Kattegat – the sea between Denmark and Sweden – arriving on 6 September 1864 where the HMS *Aurora* rendezvoused with the Royal Yacht *Osborne*, which already had Bertie, Prince of Wales, and Alexandra, Princess of Wales onboard.

HMS *Aurora* then acted as escort during a visit to Copenhagen, Denmark, six (6) miles south of Bernstorff Palace, where, in two weeks time, Tsesarevich 'Nixa' Nicholas would propose to Princess Dagmar, on Sunday 20 September 1864.

Six days later, to pick up Bertie, Prince of Wales from the Fredensborg pleasure Palace and hunting lodge on Monday 26 September 1864, HMS *Aurora* and the Royal Yacht *Osborne* moored in Helsingør Harbour and Bertie travelled 10 miles WNW to the coast to Shakespeare's Elsinore Castle (Helsingør). Both ships then left for Stockholm, Sweden 465 miles NNE ... to be away twenty-four (24) days.

The Royal Yacht *Osborne* and the tender HMS *Aurora* then left Stockholm on Tuesday 11 October 1864 and took nine (9) days at an average of 2 knots to travel the 465 mile return journey.

The Danish, Swedish and Russians were playing the British, delaying Bertie, Prince of Wales' return. Staff and crew of the Royal Yacht *Osborne* and tender HMS *Aurora* were complicit. They maintained a painfully slow journey to ensure that the short fat slow illegitimate "insane" couchon Bertie, Prince of Wales could not possibly have sired the second child, George V, and the Ship's Record would confirm this with the Admiralty ... as it has.

If they had travelled at the usual 3.5 knots, it would have taken five (5) days, but they would have arrived in a time frame in which Bertie, Prince of Wales could have sired Prince George. So Bertie was away twenty-four (24) days – his return journey taking an extra four (4) days, and he arrived at Elsinore Harbour on Thursday 20 October 1864 – a day or two after the last possible time of conception.

Instigating the programme, Alexandra, Princess of Wales delayed seeing her husband Bertie, a further day, and didn't join him until Friday 21 October 1864. Alexandra was already twenty-three (23) days pregnant. Not showing, Bertie's suspicions were not raised.

That it turned out to be a boy can be planned with the male taking long walks and drams of whiskey, with Tsesarevich 'Sasha' Alexander of Russia, soon to be Grand Duke, walking the walk, drinking whiskey, and talking the talk with Alexandra, Princess of Wales who was ready, willing and waiting.

The Royal Yacht *Osborne* and the tender HMS *Aurora* then left Denmark's Elsinore and spent the next nine (9) days sailing 750 miles, averaging 3.5 knots.

They arrived into Portsmouth on England's south coast, on Saturday 29 October 1864.¹¹

Alexandra, Princess of Wales had now achieved her goal of conceiving a King of England outside of UK Royalty, replacing the English-German with Russian – so it was now Danish.

Alexandra, Princess of Wales' Pregnancies – King George V of England is Illegitimate

Alexandra, Princess of Wales had a history of premature births. Her first child, Prince Eddy, was born nine (9) weeks premature. As an adult, Eddy still looked prematurely deformed. The rest of Alexandra's children were born four to six (4–6) weeks premature, but looked far more normal than Prince Eddy, who was a bisexual dope smoker.

Alexandra's pregnancy with Prince George lasted from Thursday 29 September 1864 to Saturday 3 June 1865 (N.S.) being 35½ weeks – 248 days instead of 280 days. This was 32 days short of a full 40-week term.

Prince George was born 4 weeks & 4 days early. This was typical for Alexandra, Princess of Wales who was a very athletic horsewoman – whereas the Royal Society would say 'a very athletic woman with the horses' ... as spoken by Elizabeth II and Princess Anne.

If Bertie, Prince of Wales had sired on Friday 21 October 1864, the future George V would have been eight (8) weeks premature, but George V showed few signs of premature birth deformity, unlike his elder brother Prince Eddy, who was born nine (9) weeks premature. Rather, King George V looked like he had reached full term, or close to it.

Tracing back from 'Birth to Conception' dates are 40 weeks, or 280 days ± 18 days, so 262–298 days. Bertie had to be sent away for longer than this, and was not allowed to return until "after 18 October 1864". In addition, Princess Alexandra delayed seeing her husband Bertie for an additional day, 20–21 October 1864.

This placed the conception of King George V in the remaining period of the Black Moon Month (26–30 September 1864), in the period when Bertie, Prince of Wales was away in Sweden for 24 days from 26 September to 20 October 1864, and separate from his wife, Alexandra, Princess of Wales for that additional day, so apart 25 days from 26 September to 21 October 1864.

The end of the Black Moon Month was 11:34 p.m. on 30 September 1864 ... so +18 days was 11:34 p.m. 18 October 1864. Anything after this was a safety measure, and 21 October 1864 was three (3) days outside the time limit of Bertie, Prince of Wales siring the future King George V.

The conception at 2:34 p.m. on Thursday 29 September 1864 and the Prince and Princess of Wales meeting on twenty-five (25) days later Friday 21 October 1864, meant that Bertie, Prince of Wales had returned 23 days after the central date of conception, and five (5) days outside the limits of that conception.

Bertie, Prince of Wales/King Edward VII (R. 1901–10) could not have sired King George V of the United Kingdom (R. 1910–36) who was thus confirmed illegitimate by ships record. This illegitimacy was registered with the admiralty – which is international.

Alexandra, Princess of Wales gave birth on 3 June 1865 (N.S.) to the illegitimate 4½ week premature Prince George Frederick Ernest Albert. This was the future King George V, whose biological father then murdered his elder brother to take the Throne of Russia, then proposed to his fiancée-widow over his newly deceased elder brother's still warm body.

King George V of the United Kingdom of Great Britain and Ireland was 'Russian and Danish', which is why he looked so much like Tsar Nicholas II – they were half-brothers and full cousins, and would swap uniforms, and be photographed together, with few picking up on the double imposter scenario. Royal Society (Illuminati) expose Bertie, Prince of Wales/Edward VII as a Cuckold

The Illuminati existed as the "Invisible College of Initiates" (British), and the 'New Reformed Invisible College of Initiates', who agreed to make themselves visible and fund 'The Royal Society', which was British, but full of repatriated Europeans.

At the time of the creation of "William Shakespeare", it was an invented name with a purpose to – "Shake the Spear of History" with "I am the Will that Shakes the Spear" (William Shakespeare). Throughout their "Shake the Spear of History" (simultaneously creating "William Shakespeare") they joined the different 'Gaelic forms of language', the Old Irish, Old Picts, and dialects spoken all over the British Isles, to form one English language.

"Shakespeare" was the Illuminati's way of modifying the English language with 'double entendres' allowing something to be said, drawn, or made, and once interpreted, revealing the secret or prediction through a second deeper meaning – in this case, the illegitimate King George V, who was not English, but Russian.

This was all part of the Kabbalah of the English language – or Cabala of the English language, or the English Cabal, or Stable of Knowledge. Shakespeare coined over 1,700 common English words by changing nouns into verbs, verbs into adjectives, connecting words never before used together, adding prefixes and suffices, and devising new words wholly original.

Through this, the 'Invisible College of Initiates' were able to create pillars for the future – the foundation of the powerful United Kingdom which became an 'Empire' where their citizens spoke one language, which became the most spoken language worldwide.

This restored the principal of Babylon's 'Tower of Babel' where the old Biblical God displays the Languages of Men. The purpose of the Tower of Babel and uniform common English was to create Anarchy, part of which is revealing corruption in Kingship!

Hence "Hamlet", slip the 'm' back a notch and add another 't' for 'Hallett'.

The world is run on predictions and we ought to know it. It is our right to know this ...

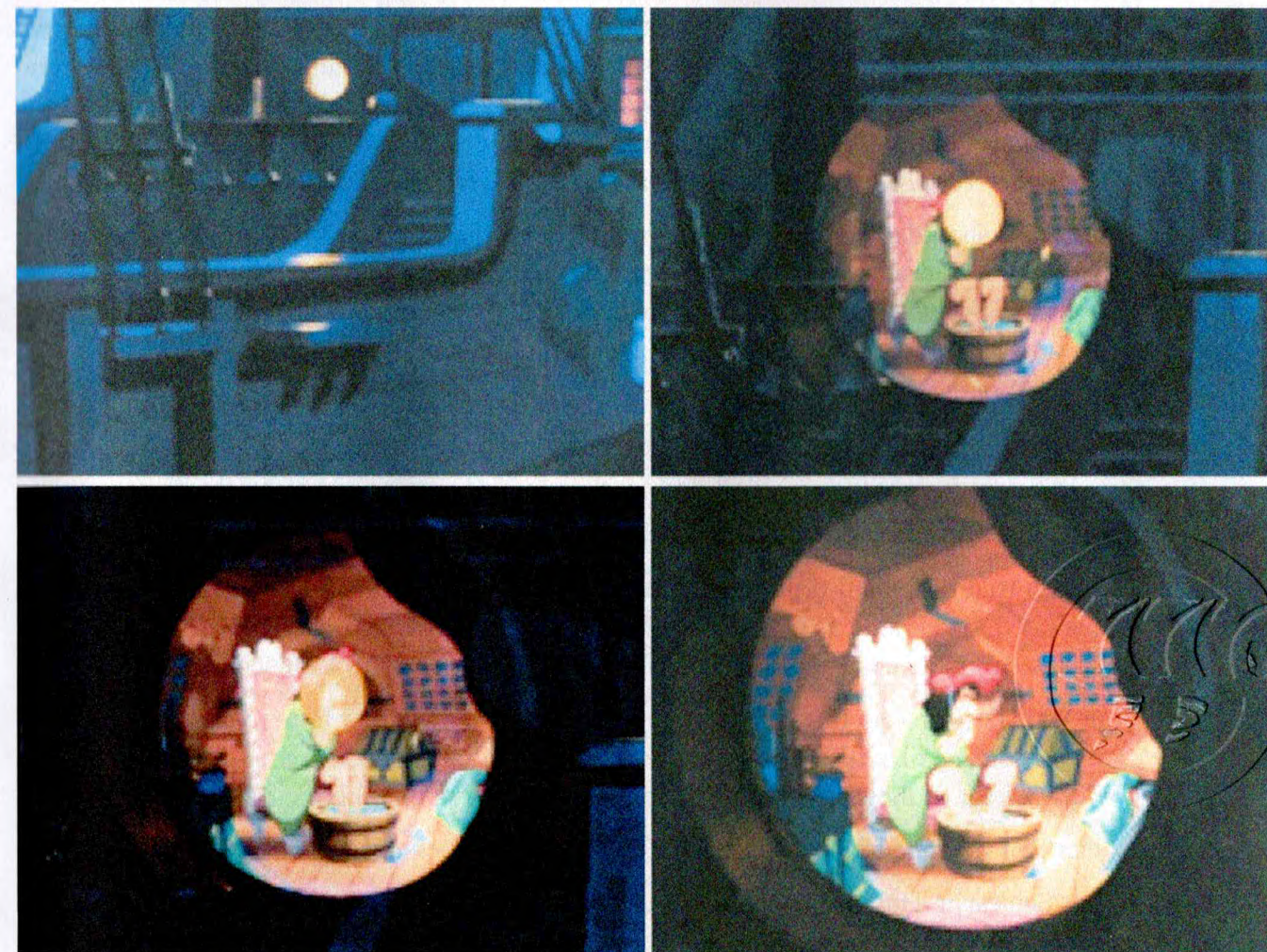
In the Illuminati Shakespeare's Elizabethan Tragedy, 'Hamlet', "Elsinore Castle" is the real Danish 'Kronborg Castle' on Helsingør (≈ Elsinore) Harbour. This is where Bertie, Prince of Wales boarded for Sweden (26 September–20 October 1864) to ensure he did not sire Prince George / King George V of the United Kingdom of Great Britain and Ireland.

The Illuminati's Shakespeare was dealing with 'Man and his Soul'. Thus, Bertie, Prince of Wales became the Illuminati's fly on the wall stripped of his wings, stripes and epaulets in Shakespeare's 'Hamlet'. 'Art imitates life' when the Ghost of 'Hamlet's Father spoke: Act 1, Scene 5:

"Wouldst thou not stir in this. Now, Hamlet, hear. 'Tis given out that, sleeping in my orchard, a serpent stung me. So the whole ear of Denmark is by a forged process of my death rankly abused. But know, thou noble youth, the serpent that did sting thy father's life now wears his crown."

Just as a Monarch without their 'hat, gloves and shoes' can be treated as a Commoner; a Monarch stripped of their 'wings, stripes and epaulets' is not to be treated as a Monarch, but as any port in a storm. This 'Port Storm' is represented in the Illuminati's Disney 1953 movie 'Peter Pan' where Captain Hook ~ Bertie, PoW / KEVII, is shown through the porthole with 'a cold', then presenting the tattooed Pirate ~ "the Sailor Prince" George as though he was proudly presenting his son. This would equate to King Edward VII presenting George, Prince of Wales who was known as the 'Sailor Prince'.



The also illegitimate Bertie, Prince of Wales became King Edward VII (R. 1901–10) and five weeks before his death, Edward VII murdered his 7½-year elder legitimate brother, Prince le Favori Marcos Manoel, King John II of the United Kingdom of Great Britain and All Ireland (R. 1869–1910). Prince Marcos Manoel was known as "le Favori" because he was Queen Victoria's favourite, and first-born, and only legitimate child.

The Royal Society have Queen Elizabeth II and Princess Anne as head patrons, with the goal to remove Governments and just have a Monarchy. In October 2012, one of their dedicated life-long members approached Joseph Gregory Hallett in Holland and stated:

"Alexandra, Princess of Wales was known to be having sex with horses; this was known by Queen Elizabeth II and Princess Anne, who held this to be true".

'Sex with horses' is also code for a 'dragon' and could be codified as 'a dragon'.

Alexandra, Princess of Wales was an excellent dancer and horsewoman, riding while pregnant – the dragon. Her speciality was tandem carriage driving with one horse in front of the other. She was also photographed with a dragon-style hairdo and veil.

The 1953 'Peter Pan' movie represented the conception of King George V as a Pirate with Dragon Tattoos. If we take Captain Hook as Bertie, Prince of Wales / King Edward VII and the tattooed Pirate as the tattooed "Sailor Prince" George / King George V, then the Disney Sailor's tattoos tell the story of King George V's conception and birth.

Tattooed on his right arm tucked behind his back, the dragon has two tails indicating 'two fathers'. Tattooed on solar plexus, sympathetic nervous system, or ganglia, a second dragon represents a dancing pregnant woman giving birth to a dark figure with crown – the illegitimate 'Sailor Prince' King George V conceived during the Black Moon month of September 1864, when Denmark was at war with Germany (February–October 1864).

Where his shoulder meets his left arm (right side) is the Schleswig-Holstein Line, becoming the new pro-German border with Denmark, which sticks out like a clenched arm. The "Schleswig-Holstein Question" came to divide Denmark (left arm) from northern Germany (the torso) confirmed by the two mermaids with red hair.

So was this a Question, or is it a Line for those in the know.

The German-Danish Line or German-Danish Question was flaring up during the time of King George V's conception. In Illuminati fashion, his conception was in Question and would flare up like a dragon, and breathing fire.

Thus in true Illuminati fashion, simultaneous history played out on multiple levels, to be illustrated via cartoon as an allegory, for birth, death, marriage, war, national boundaries, and the complete change of kingship, from English-German to Danish-Russian.

As Walt Disney was Illuminati, he knew what to include and how to represent it, right down to the detail, which he placed on the tattooed pirate in his 'Peter Pan' movie, released within a year of the death of King George VI, who died on 6 February 1952.

Peter Pan was released on 5 February 1953 by RKO Pictures ~ 'Regal King Out'.

The "Schleswig-Holstein Question" resulted in the First Schleswig War where Prussian forces crossed the German border into southern Denmark (24 March 1848–31 December 1850), then the Second Schleswig War (1 February–30 October 1864) which enveloped the Black Moon conception month of September 1864 ... even though Alexandra, Princess of Wales' father, King Christian IX of Denmark, had signed the preliminaries of a peace treaty renouncing his rights to approximately 340 by 70 miles of duchies, including the cities of Hamburg and Hanover, to the King of Prussia and Emperor of Austria on 1 August 1864.

Sixty (60) days later, the illegitimate conception of King George V took place in Denmark.

Prince Victoria had married Blind Prince George of Cumberland on 9 March 1834, and never divorced. At the time, Queen Victoria's first husband was Blind King George V of Hannover (R. 1851–66). Queen Victoria and Bertie, Prince of Wales absolutely hated each other, and would constantly sabotage, as Bertie was conceived by rape under the influence of Scopolamine, sired by the London Central Banker, Lionel Nathan Rothschild.

So Queen Victoria was not entirely adverse to the shenanigans, initially plotted against her.



Captain Hook as King Edward VII (R. 1901–10) proudly introduces his illegitimate non-son, the tattooed "Sailor Prince" and future King George V (R. 1910–36). His mother, Alexandra, Princess of Wales with dragon hairdo, watches as her Danish-Russian tattooed prodigy takes the German-British Crown and degenerates it.

Royal Excuses

In his 1992 *Edward & Alexandra, Their Private & Public Lives*, Richard Hough (1922–99) offers the excuse that Alexandra, Princess of Wales lied about the dates she conceived, and consequently the dates she was due 'because she didn't want Queen Victoria pestering her about the birth'.

Richard Hough wrote ninety (90) books in his lifetime and was accredited with being an historian who specialised in maritime history, yet he had joined the RAF from school, but was stationed near Hollywood, USA.

Most of his books were children's books, and not about maritime events, nor about Royalty.

Richard Hough was a British Air Force and Naval Intelligence Agent.

Most of these agents look nothing like it, and do nothing like it.

Intelligence calls this "cover" and "deep cover", so when they're called up, they appear 'independent'.

It was as if Richard Hough was commissioned to write propaganda for the British Royal Family, and indeed he was.

Hough also wrote under the pen name "Bruce Carter". Being a children's story writer, Richard came across the Black Moon month in Russian and Scandinavian folklore fairytales.

Contrary to Richard Hough's false claim attributing Alexandra, Princess of Wales "lied about conception & due dates because she didn't want Queen Victoria pestering her about the birth" ... Queen Victoria hated babies, stated they were the ugliest of things, referred to them as 'frogs', and only saw her nine (9) official children once they were three months old, then once every three months, and then briefly. Queen Victoria to Princess Vicky:

"I have no adoration for very little babies ... An ugly baby is a very nasty object ... and the prettiest is frightful when undressed ... Leopold ... is the ugliest ... I think he is uglier than he ever was ... I never cared for you near as much as you seem to about the baby; I care much more for the younger ones (poor Leopold perhaps excepted) ... We used to constantly see you and Bertie in bed and bathed – and we only see the younger ones – one in three months perhaps."¹²

Tsar Alexander III of Russia sired King George V of the United Kingdom of Great Britain and Ireland.

Tsar Alexander III of Russia ruled Russia, 1881–94, and his son, King George V of the United Kingdom ruled England, 1910–36.

King George V helped his half-brother and first cousin, Tsar Nicholas II get out of Russia.
